



AOR Coordination

- The RPEC is responsible for all environmental and planning work within the SWT, SWF, SWG and now SWL boundaries.
- All work that physically occurs outside of the SWD boundaries must be coordinated through the Division Office POCs.
- No Exceptions including programs for which there is an MOU or MOA in place.

Acquisition Steps

- Pre Solicitation Documentation (market research, acquisition strategy, etc.
- Develop all parts of the RFP (Sections B, C, L, and M)
- District Approval (Contracting, Legal)
- PARC/HQ (Principle Assistant Responsible for Contracting)
- Post to FEDBIZOPS
- 30 day minimum RFP
- Proposals received
- Review/consensus
- Board Report contracting/legal reviews, PARC review.
